

Non-English language declaration

If any applicant for the International Prudence Bond (Spain) is a national of a country where English is not a primary or official language, they need to complete and submit a signed declaration in their native language before we can process their application.

Countries where English is a primary or official language are detailed overleaf and nationals of these countries don't need to submit a declaration.

If you need a declaration please speak to your account manager. When you get the declaration, please pass this to your client to sign, and then send us both the declaration and the application form at the same time.

The declaration that will be used has been provided in English for information purposes only.

Important information for joint applications

Where applicants are from different countries where English again is not the primary or official language, we need a declaration from each applicant in their own language.
